Information about the event

In a resolution adopted on the 8th of October, EU lawmakers urged member states to ensure that young people who enroll for the Youth Guarantee schemes are offered "good-quality, varied and tailored job, training, apprenticeship or internship offers, including fair remuneration". The text condemns the practice of unpaid internship as "a form of exploitation of young people's work and a violation of their rights. What will be the concrete repercussion of such a decision from the European Parliament?

Simultaneously, the SPRINT project, a strong consortium of employers, universities, intermediary organizations, trade unions and youth NGOs have released a European (pre-)standard for quality internships approved by the European Committee for Standardization (CEN) – document here.

The event will bring some clarification on the political context and present solid and concrete solution to foster quality and paid internships.
